

## Sammanställning

### Tidöavtalet

Regeringen har sedan den tillträdde 2022 jobbat aktivt med frågor inom migration och integration, vilket bland annat har resulterat i de förslag som anges i Tidöavtalet. Nedan följer en översikt över de statliga utredningarna inom området som hittills har initierats under mandatperioden.

Regeringen vill genom mottagningscenter skapa ett samlat mottagande i statlig regi för asylsökande i Sverige. Utredningen ska, mot bakgrund av detta, föreslå hur en skyldighet för asylsökande att bo i mottagningscenter kan utformas.

Regeringen vill se en ökad återvändning från Sverige. Mot bakgrund av detta tillstöttes denna utredning för att se över vilka incitament som ligger till grund för frivillig återvändning samt hur dessa kan stärkas för att bidra till ökad återvändning.

Utredningen har därför fått i uppdrag att se över hur möjligheterna att återkalla uppehållstillstånd kan utökas samt hur möjligheterna att avlägsna utlännningar ur landet om det finns brister i deras levnadssätt kan stärkas.
